St. Mary's County Health Department's <u>Clear Water® Program</u> locally administers the Bay Restoration Fund – an ongoing grant program that awards grants to residents and small businesses. In many cases, these grants cover all expenses to upgrade septic systems and include maintenance costs for two years.
